Additional clarification:

1. In "MONTHLY ROUTINE SERVICES" It states:

- Contractor shall provide a minimum of eight (8) on-site service hours per month. Monthly visit schedule will be pre-arranged with the selected contractor and the CMAA.

- [Contractor shall check all logs from security systems](#), and DVR/NVRs and provide CMAA with recommendations to identify and resolve potential or actual problems taking place in the system. [The information in yellow is correct.](#)

Is "Security Systems" only referring to Airport Video Monitoring System and DVR/NVRs? [Yes](#)

Does "Security Systems" include the existing Access Control System? [No this is just for the cameras.](#)

2. In EXHIBIT "A" RFP: AIRPORT VIDEO MONITORING SYSTEM Bid Sheet

It States: Provide pricing for the cost of software and license requirements, installation, and maintenance of [keycard access control system services](#), and other associated costs in this section. Additionally, provide a separate service call price sheet of services being offered

3. Is CMAA seeking a comprehensive equipment and labor warranty on all system components, including all troubleshooting, repair, or replacement, and licensed major system version upgrades which are proven and available within the contract term, and all supporting network and coaxial cabling, switching equipment, and power supply equipment**OR**.....

[We want a warranty for all new installations labor and equipment for a period of time up to one year.](#)

Is CMAA seeking a base preventive maintenance contract, with any troubleshooting, moves, adds, and changes billable at stated rates on a case-by-case basis [Preventive maintenance is what we would require](#)

If comprehensive coverage is desired, please provide the following information of the equipment to be covered, in order for bidders to estimate their liability:

- Itemized BOM of camera sensor equipment, service history, manufacturer warranty expiration date (or install date, if that is easier to produce), any manufacturer warranty extensions purchased at the time of installation [Please see camera list below for make, model and serial numbers. There is not an active list of service history or warranty expiration. Most cameras have exceeded their warranties. The existing service agreement includes comprehensive labor and equipment coverage, which effectively serves as an extended warranty for the systems. We are NOT interested in including comprehensive equipment coverage in this new contract, and will instead replace equipment at CMAA's discretion, at CMAA's cost, or at security contractor's recommendation.](#)
- Itemized BOM of Server Equipment, including the same above information, and age and quantity of storage drives. [There are 3 NVRs, all less than 3 years old.](#)
- Itemized BOM of any Network attached storage appliance used for backup purposes, including the above information and age and quantity of storage drives [N/A we don't have network storage.](#)
- Itemized BOM of Analog camera equipment and DVRs which should be comprehensively covered, including the same above information, as possible [N/A we don't have any DVR Analog cameras that will be replaced.](#)
- Itemized BOM of camera network equipment which should be comprehensively covered, including the above information - this need not include small components such as media converters, SFP modules, patch cables, etc [CMAA will cover network equipment in house.](#)
- Itemized BOM of UPS units to be comprehensively covered, including the above information and service history. [This is covered in-house by CMAA.](#)
- Itemized BOM of workstations and the above information on those. [There are four computers, all running Windows 10, and less than five years old.](#)
- As-built drawings of the existing system to be warrantied, with key info redacted for security purposes, if necessary. [Currently, CMAA does not have an as-built layout of our security camera network layout. This is something that may be requested as an additional service once the contract is awarded.](#)
- Current ACC channel license count and version. [There is currently no such agreement in place. This is something we would prefer to have taken care of on CMAAs behalf in the future.](#)
- Any software upgrade assurance licenses in place which provide no-cost migration to the next major version. [We currently do not have any software upgrade assurance licenses in place. This is something that can be implemented after contract execution at CMAAs expense.](#)
